We appreciate you putting your trust in our competition. It is our mission to be the fairest and most comprehensive cannabis championship of its kind. Our judging is and always will be completely fair, unbiased and educated. We will gather judges from across the state. Some of which will work in the industry and some will simply be patients. This year we have made some big changes to our judging. We have not only expanded our judging panels from 10 to 20 judges per category, we have also partnered with the world renowned Oaksterdam University to assist in setting our judging criteria and scales, and also to personally train all of our judges. Our judges will receive blind, coded samples for each entry with the exception of the edibles and tincture categories which we have changed to “branded” categories this year. In our best efforts to make sure the judges receive the samples in the same condition in which they were submitted, we have partnered up with Custom 420 Northeast to provide quality packaging for the blind judging process. With each entry you receive (1) weekend pass to the event. Your wristband and contestant badge will be available at our will call / vendor information booth the weekend of the event.

Drop off Instructions:

We will be picking up entries at several locations this year on specific dates. You may submit your entry at the location of your choice. We will be on location from 1:00 p.m. – 6:00 p.m. If you are in line by 6:00 p.m., we will accept your entry.

ALL ENTRIES MUST BE SUBMITTED WITH ITS APPROPRIATE TEST BY AN OKLAHOMA CERTIFIED TESTING LABORATORY. Express Toxicology Services will be performing a 2nd full panel test on each entry. A copy of this test will also be sent to you.

WE WILL BE USING ARCADIA BRANDS TO PROCESS OUR JUDGES PACKS THIS YEAR. YOU WILL BE MAKING A NORMAL TRANSACTION WITH THEM AND WILL DROP OFF A SAMPLE WITH EXPRESS TOXICOLOGY SERVICES.

WHAT YOU WILL NEED TO BE LEGAL AT DROPOFF LOCATION:

- (1) Two separate manifests with all of the required information.
 - a. Manifest to express will be for either 7g flower or 2oz topicals or 3g concentrates/carts or 3 ea prerolls and/or edibles.
 - b. Manifest to Arcadia will be for the remainder of your entry quantity. (Entry Qtys listed below)
- (2) Invoice to Arcadia for the remainder of your entry quantity for \$1.00.

Concentrate Entries

Concentrate entries must be submitted in bulk in a ½-pint mason jar with the exception of the Shatter and Carts categories. Shatter may be submitted in (30) ½ gram samples in parchment paper or equal packaged together in a separate sealed container. Carts can either be submitted in 1 gram or ½ gram cartridges but must equal 30 total samples packaged together in a separate sealed container. Containers must be labeled with the following and be accompanied by their respective test results.
